I, _____, am the parent of the minor in the above entitled matter. I understand that I am charged with contempt pursuant to Code of Civil Procedure Section 1209 (a)(5) for violation of a court order.

I understand that I am charged in the Order to Show Cause Re Contempt filed on _____ with _____ count(s) of contempt for violation of the order(s) of this Court.

I understand that the elements of contempt for violation of a court order are:

1. There was a valid court order.
2. I had knowledge of the order.
3. I willfully violated the order.

I understand that the defenses to contempt are one or more of the following:

1. There is no valid court order.
2. I did not know about the court order.
3. I did not willfully violate the court order.

I understand the penalties for a finding of contempt under Code of Civil Procedure Section 1218 for the violation of a court order are:

Five (5) days in jail or a fine of up to \$1,000, or both, for each count of contempt.

ALL PROMISES MADE TO ME CONCERNING THIS PLEA ARE AS FOLLOWS:

INDICATED JUDGMENT OF COURT:

The Court has indicated to me that if I enter a plea of guilty to all counts of contempt alleged in the Order to Show Cause and Affidavit re Contempt, I will be placed on probation for a period of time equal to the duration of the Child Welfare Services Case Plan. In addition, the Court has indicated that the following terms and conditions of probation will be imposed:

1. I will be required to participate in, or continue my participation in the Dependency Drug Court Treatment Program as a part of the Child Welfare Services Case Plan.
2. I will be required to comply with all orders of the Juvenile Court Judge and all conditions of the Child Welfare Services Case Plan.
3. I will waive all of my due process rights as set forth in the attached form entitled **ACKNOWLEDGMENT AND WAIVER OF DUE PROCESS RIGHTS** and all of my constitutional rights as set forth in this **WAIVER OF CONSTITUTIONAL RIGHTS AND PLEA OF GUILTY TO CONTEMPT** form as they would apply to any violation of these terms and conditions of my probation.
4. I will consent to the Court's imposition of any portion of the jail time that could have been imposed upon the entry of my plea of guilty to the contempt charges in this case if the Court, in its absolute discretion, should find that the imposition of all or any portion of that jail time is appropriate for a violation of any term or condition of my probation. I understand that any sanction will be imposed immediately, without notice, hearing, or right to assistance of counsel.
5. I will consent to be housed with the general population at the Tuolumne County Jail if ordered to serve any time in the Tuolumne County Jail as a result of a sanction for violation of any term or condition of my probation.

**ACKNOWLEDGMENT AND WAIVER OF
DUE PROCESS RIGHTS**

I acknowledge and understand that in addition to the constitutional rights that are set forth in the attached plea form, I have the following due process rights that I hereby waive as a condition to the imposition of the indicated judgment in the attached Waiver of Constitutional Rights and Plea of Guilty to Contempt form.

1. The right to advance notice, either written or verbal, of any violation of a term or condition of my probation in this case.
2. The right to have an evidentiary hearing to establish a violation of a term or condition of my probation in this case.

4. The right to remain silent.
5.
